We as a family have been trying to get information about BarbaraJean Rose (correct spelling) since June 13, 2025 (heard it through the grapevine) that she, my Aunt, had a medical emergency and was unresponsive in her home for atleast two days located at: 3040 SORBONNE DR, MARRERO, LA 70072-5560.

EMS took her to West Jefferson Medical Center in Marrero. The last trace of information about her last location other than New Orleans Crematorium was Living in Love LLC located at 1712 Holiday Drive, New Orleans, LA.

Why are we as a family so lost as what where and where, you ask? Well, there are two individuals that has claimed to be her children. My Aunt had "one girl child" that tragically died in a car accident at the age of five in 1973 and her name was Sandra, my first cousin.

These two individuals also has withheld information about EVERYTHING. We as a family did our own footwork and located her then to be told by the last facility that my Aunt's family was banned by her son, Gershalia Terrence Dixon at (504) 931-0597.

Mr.Gershalia Terrence Dixon is claiming to be her son and stated he has/have/had a POA signed by my Aunt. To date he has not produced this specific paperwork (POA) to any of her living siblings. Now my Auntie is dead, cremated when her whole family knew she wanted to be donated as a cadaver for Science purposes.
